July 1, 2019

The Mayor and Board of Commissioners of the City of Sweetwater met in their regular monthly meeting on Monday, July 1, 2019 at noon. Commissioners present being: Lamar Hughes. Commissioners-Elect present being: Sam Moser, Alan Richeson, and Billy G. West. Mayor Doyle F. Lowe opened the meeting with the Lord's Prayer, followed by the Pledge of Allegiance, led by Police Chief Eddie Byrum.

Commissioner West moved to appoint Richard Jenkins as Street Superintendent, with Commissioner Hughes seconding the motion. All voted in favor, with none opposed. The motion was carried.

Commissioner Moser moved to appoint Chuck Whited as the Department Head over Planning, Development, & Tourism, with Commissioner Hughes seconding the motion. All voted in favor, with none opposed. The motion was carried.

Commissioner Hughes moved to appoint Tim Crawford as Parks and Recreation Director, with Commissioner Moser seconding the motion. All voted in favor, with none opposed. The motion was carried.

Commissioner Hughes moved to appoint Sam Moser to the Planning Commission, with Commissioner Richeson seconding the motion. All voted in favor, with none opposed. The motion is carried.

Commissioner West moved to appoint Alan Richeson to the Sweetwater Library Board, with Commissioner Moser seconding the motion. All voted in favor, with none opposed. The motion is carried.

Commissioner Richeson moved to appoint Sam Moser as Personnel Commissioner, with Commissioner Hughes seconding the motion. All voted in favor, with none opposed. The motion is carried.

Commissioner Moser moved to appoint Billy G. West to the Sweetwater Heritage Museum Board, with Commissioner Hughes seconding the motion. All voted in favor, with none opposed. The motion is carried.

Mayor Lowe moved to citizen appointments to boards. Commissioner Hughes moved to appoint Jim Stutts, Karen Sadikoff, and Marty McCambell to the Sweetwater Library Board, with terms expiring 7/1/2022. Commissioner Richeson seconded the motion. All voted in favor, with none opposed. The motion is carried.

Commissioner West moved to appoint Lloyd Moree to Sweetwater Utilities Board with a term expiring 6/30/2023. Commissioner Hughes seconded the motion. All voted in favor, with none opposed. The motion is carried.

Commissioner Moser moved to appoint Jill Alliman to the Sweetwater Tree Board with a term expiring 7/1/2023. Commissioner Richeson seconded the motion. All voted in favor, with none opposed. The motion is carried.

Commissioner Hughes moved to appoint Shelby Billingsley, Richard Barr, and Kevin Watson to the Sweetwater Recreation & Parks Commissioner with a term expiring 6/30/2021. Commissioner Richeson seconded the motion. All voted in favor, with none opposed. The motion is carried.

Commissioner Richeson moved to appoint Brent Miller and Sam Moser to the Historic Zoning Commission with terms expiring 6/30/2023. Commissioner Hughes seconded the motion. All voted in favor, with none opposed. The motion is carried.

Commissioner Hughes moved to appoint Sam Moser to the Building Codes Board of Review, with Commissioner Richeson seconding the motion. All voted in favor, with none opposed. The motion is carried.

Commissioner West moved to appoint Mary Ann Upton and Rebecca Collette to the Sweetwater Heritage Museum board with terms expiring 7/1/2022. Commissioner Hughes seconded the motion. All voted in favor, with none opposed. The motion is carried.

Mayor Lowe requested the board table the appointments to the Industrial Development Board until nominations were received. The item was placed on the August agenda. He noted he appointed Mr. Branham Lovingood to the Sweetwater Planning Commission with a term expiring 6/30/2026.

City Recorder Jessica Morgan recommended the following depositaries for city funds: Capstar Bank, People's Bank, Simmons Bank, State of TN Local Investment Pool. She requested the board authorize two changes. She requested authorization to add an additional Capstar account at a higher rate of return comparable to the State of TN Local Investment Pool and requested the board authorize her to close the Regions account for ECD and move the funds to Volunteer Federal, as Regions was charging a monthly fee on the balance. She requested the same signatories on the new account, being Recorder Jessica Morgan, Mayor Doyle F. Lowe, Shannon Creasman, and Sonya Crush. Commissioner West moved to authorize the depositaries and changes as recommended by the Recorder, with Commissioner Hughes seconding the motion. All voted in favor, with none opposed. The motion was carried.

No further action was taken. Mayor Lowe thanked Commissioner Edward Lee for his service to Sweetwater and welcomed Commissioner Alan Richeson to the board. He invited everyone to stay for refreshments.
