The January distributions report was reviewed by the Recorder. Commissioner Hughes moved to approve the distributions, with Commissioner Richeson seconding the minutes. All voted in favor to approve the minutes, with none opposed. The motion was carried.

In New Business, Mayor Lowe reviewed the 5-year Capital Improvement Plan and the item was placed on the February workshop for further discussion.

Commissioner Richeson moved to approve the Resolution regarding tax sale opening bid for AdValorem taxes only. Commissioner Moser seconded the motion. All voted in favor, with none opposed. The motion was carried.

not expected to attract any bids if the bidding is opened for the sum of the *ad valorem* tax plus special assessment; now,

Therefore, **BE IT RESOLVED** by the Mayor and Board of Commissioners of the City of Sweetwater that the Clerk & Master open the bidding on Tax Map

23B, Group A, Parcel 007.00, for only the amount of the <i>ad valorem</i> taxes (including interest and other statutory costs and fees).
