## **Beer Application Permit**

Please note: This application must be completed in its entirety in order to be presented to the Sweetwater Beer Board. It must be returned no later than 15 days before the meeting date in order to process the background checks and be added to the meeting agenda. EVERY QUESTION MUST BE ANSWERED.

## **INSTRUCTION SHEET**

Permits shall be issued to the owner of the business, whether a person, firm, corporation, joint-stock company, syndicate, or association.

A permit is only for a single location and is valid for all decks, patios, and other outdoor serving areas that are contiguous to the exterior of the building in which the business is located.

Where an owner operates two or more restaurants or other businesses within the same building, the owner may, in his or her discretion, operate some or all of such businesses under the same permit.

A permit is valid only for the business of the owner named in the permit.

A permit holder must return to the county or city that issued it within fifteen (15) days of termination of the business, change in ownership, relocation of the business or change of the business name. A change in ownership occurs for a corporate owner when at least fifty percent (50%) of the stock of the corporation is transferred to a new owner.
