SECTION 1: INTRODUCTION & COMMUNITY PROFILE

MISSION STATEMENT: To provide our citizens with options for healthier lives and recreation to promote their quality of life, preserve and protect public assets, and establish unique examples of natural, cultural, and scenic areas and provide a variety of safe, quality experiences through an accessible system of city parks and facilities.

City Background

The City of Sweetwater, Tennessee was founded in the 1850's as a result of a land sale to Isaac Lenoir, son of the founder of Lenoir City. The City was officially incorporated in 1875. Situated along Sweetwater Creek, the City lies in Monroe County, TN and within the Sweetwater Valley. Sweetwater is also near to the largest underground lake in the continental United States, The Lost Sea. This is a major tourist attraction for the area and draws over 150,000 visitors annually. The City was home to the late Harry T. Burn, a local attorney and politician who broke the vote on the 19th amendment that gave women the right to vote. Sweetwater's downtown district is a National Main Street community and proud Tennessee Downtown Designee. The historic downtown area has been revitalized and draws many visitors to its shops and historic locations every year.

Sweetwater Parks and Recreation

Sweetwater Parks and Recreation Department has recently achieved Tier 1 Benchmarking. This department also keeps busy by maintaining all city buildings. The department anticipates that the next several years will bring major renovations and additions to the parks and recreation facilities. Sweetwater Parks & Recreation is proud to have recently completed Phase Two of Engleman Park, which added a splash pad, 3rd pavilion, swing set, additional parking and restrooms, in partnership with the State of TN LPRF Grant program. The Sweetwater Parks and Recreation Department is responsible for maintenance and upkeep of baseball fields, football stadiums, basketball courts, walking trails, public stages, soccer fields, tennis courts, swimming pools, picnic facilities, and meeting rooms. Sweetwater is home to six public parks: Engelman Park, Duck Park, Circle Park, Jones Park, the Sweetwater Recreation Complex, and the newly added Wiggly Field Dog Park.

Community Profile

The community make up is an important aspect to understanding the age and demographics of a community. This allows for a thorough look into what needs and recreational services are likely to be used by the local populace. Lifestyle preferences, financial capability, and social diversity are all things that need to be considered when planning for a recreation project. As of 2022, the City of Sweetwater is home to 6,422 residents. This is an increase over 2020, which was 6,312 residents. The average annual income of residents in Sweetwater was \$52,328 with a poverty rate of 19.48%, which is significantly higher than the national average of 11.6%. The average age of residents is 40 years old. The student population (K-12) of Sweetwater is 1,451 students.



SECTION 2: DEMOGRAPHICS

Demographic data is important because it allows us to analyze the economic and financial situation of the community to better assess and make decisions based on the population. We also look at educational attainment (Table 2-1) and average household income (Table 2-2) to see what economic sectors most of the population participates in.

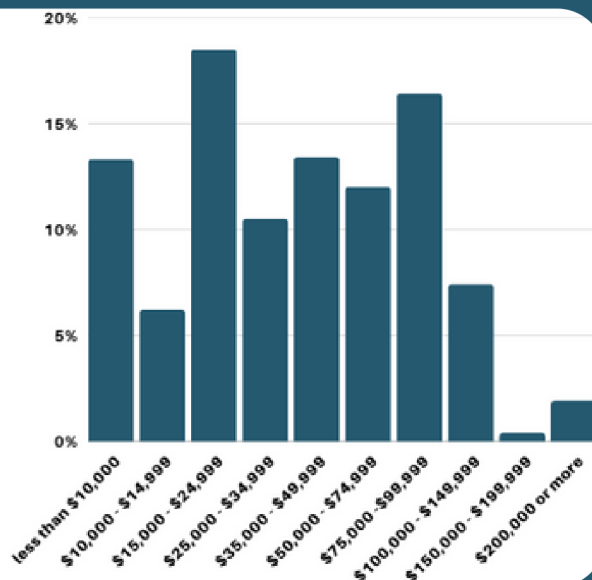

Educational Attainment

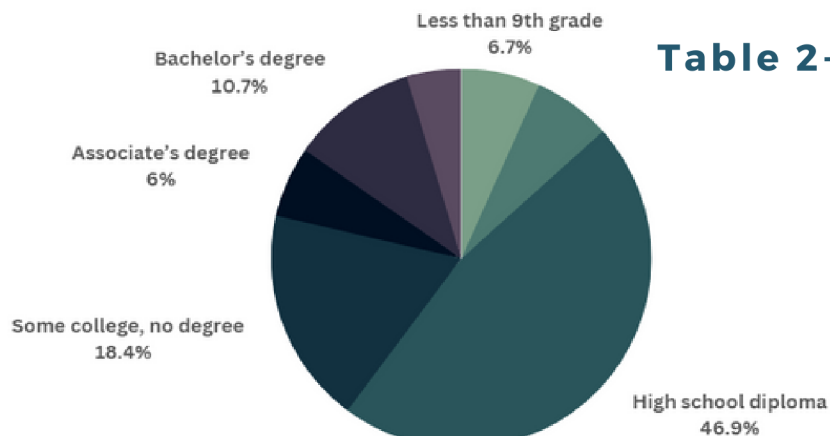

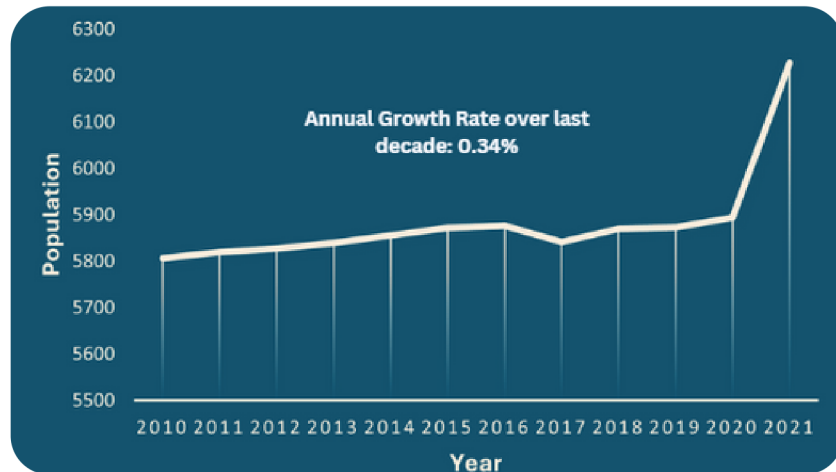

Sweetwater Population

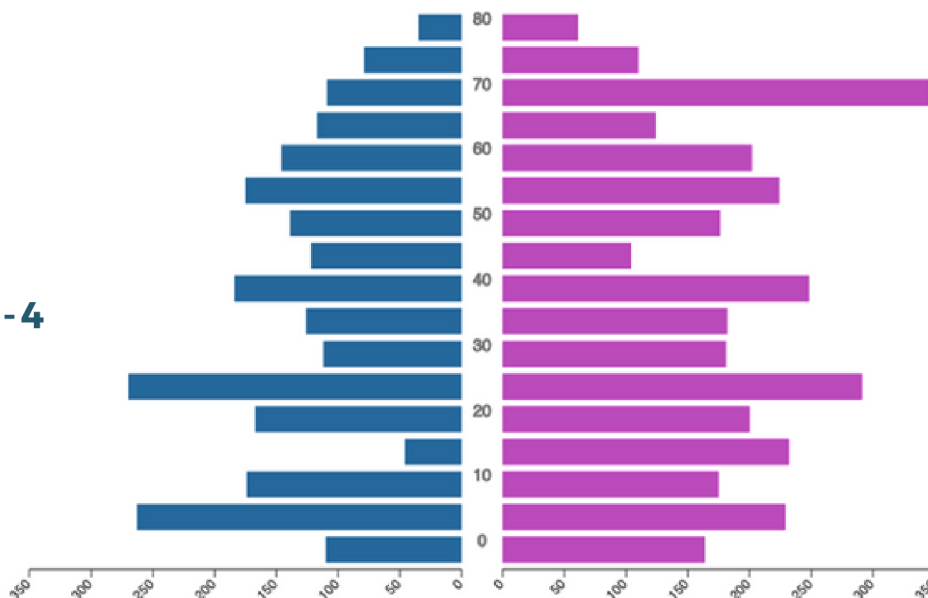

Maintenance Review

Pool Maintenance Plan

Purpose: To outline the guidelines for maintenance of the city-owned pool & Splash Pad

Financial Resources: The City of Sweetwater provides a line item in the annual budget within the parks and recreation department for pool & splash pad maintenance. The Parks and Recreation Director or his designee shall have authority to disburse the budgeted funds for routine playground maintenance as needed. The city also employs a full time parks and recreation department with at least one employee trained specifically for pool inspection.

Financial Administration: The pool is currently located on city-owned property, which includes the Recreation Complex. The pool is funded and maintained through the city's budget, according to the city's purchasing and accounting policies. Funding is ultimately determined by the Mayor and Board of Commissioners. The City covers both property and casualty coverage on their blanket policies.

Staff Qualifications: The parks and recreation department has at least one staff member trained for pool maintenance. Currently, the pool supervisor is Scott Duckworth. The Pool Manager is hired annually by the Parks and Recreation Director and Commissioner. The pool manager, city recorder, parks director, and parks commissioner hire the seasonal staff of lifeguards. Each lifeguard is certified bi-annually by a certified instructor. The city is pursuing having one employee certified to train lifeguards to help lower the cost of certification and relieve scheduling issues. Lifeguards are hired seasonally, but typically serve multiple years.

General Maintenance Procedure: During the offseason, the pool is drained, cleaned, and inspected for cracks and damage to the surface. Any cracks or damage are repaired with hydraulic cement and marble dust. The pool is usually painted annually.

When pool season is open, the Pool Supervisor inspects the pool and area daily. Prior to opening hours, he checks the chemical levels and adjusts as needed. He vacuums both pools to remove debris. He inspects the general area for any maintenance issues. At the end of each pool operation day, the lifeguards and manager pick up trash, left items for the Lost and Found, and clean the bathrooms. Twice a week, the sand filter is backwashed to remove grass and debris. He also maintains the chemical inventory and reorders when necessary. MSDS information is stored with chemicals.

At the end of the pool season, the pool level is lowered so that freezing doesn't damage the pool surface and skimmer. The water is turned off and lines and tanks are drained and winterized.

Routine Inspections: The parks and recreation department's director, Tim Crawford, conducts weekly formal inspections. Records are kept on file by Mr. Crawford and kept available for public inspection in the Parks office. An annual inspection is conducted by Tennessee Municipal League Loss Control specialist. Informal weekly inspections are performed by various staff who work in the recreation areas, primarily looking for signs of vandalism. Any damage or potential safety hazards will be addressed as soon as possible by parks and recreation staff. Minor damage may be repaired by qualified city staff, using available funds. When necessary, a contractor may be used to repair damages or replace equipment, following the city's standard purchasing procedures. Damage that requires an insurance claim or police report shall be reported to the City Recorder. The Pool is monitored by security cameras.

Restricted Access: If at any time any piece of equipment is deemed unsafe, it is immediately lined off with police or construction tape until the problem is remedied. Access is not permitted until the problem is resolved.

Trash Receptacles: Trash receptacles are available near the area and are emptied daily during pool season, and sometimes more often depending on usage. A volunteer removes litter from the area three times per week. City staff also remove litter when necessary.

Licensing: The pool, kiddie pool, and concession stand are all inspected annually by the Department of Health and licensed by the State of Tennessee. The city recorder renews the license. The license is displayed at the pool in public view.

Playground Equipment Purchasing and Warranty: Any new equipment purchases, or repair needs will follow the city's purchasing procedures for quotes, bidding, records, and accounting. When new equipment is purchased, a copy of the applicable warranty will be kept with the purchasing documents in the Recorder's office. Significant damage or vandalism shall be reported to the City Recorder upon discovery. If a police report is deemed necessary, witness reports should be obtained by recreation staff or the police department.

Field Maintenance Plan

Purpose: To outline guidelines for maintenance of city-owned ballfields

Financial Resources: The City of Sweetwater provides a line item in the annual budget within the parks and recreation department for field maintenance for baseball, football, softball, soccer, playgrounds, and "other". The Parks and Recreation Director or his designee shall have authority to disburse the budgeted funds for routine playground maintenance as needed. The city also employs a full time parks and recreation department with all employees trained to inspect.

Financial Administration: The fields currently located on city property include the Recreation Complex and the softball complex and the Jr. High field. All are funded and maintained through the city's budget, according to the city's purchasing and accounting policies. Funding is ultimately determined by the Mayor and Board of Commissioners. Donations for fields are placed in a restricted account dedicated to parks and recreation improvements. The City covers both property and casualty coverage on their blanket policies.

Staff Qualifications: The parks and recreation department has all staff members trained for field maintenance. The majority of the training is done on-the-job. No formal training program exists, but we have at times brought in field maintenance authorities for advice.

General Maintenance Procedures: The Parks and Recreation employees all work on the fields throughout the year. Grass fields include the football field and 3 soccer fields. General maintenance for soccer fields, which are a Bermuda mix, includes mowing twice a week during soccer season, The nets are checked weekly. The area is inspected for vandalism at least weekly. General maintenance for the football field, which is Bermuda grass, includes mowing three times a week during the season with a reel mower. All grass fields have a dormancy period when no use is allowed with signs posted for maintenance. The grass fields are aerated once annually. Dirt fields include the 3 baseball fields and 3 softball fields. These fields have grass outfields and dirt infields. At the start of the season, the fields are drug with spikes, conditioned, and if necessary, sand is added. During season, the infields are spike dragged twice a week and wire-drug every day. The outfields are mowed twice a week. Fences are inspected twice weekly during the season for vandalism and/or wear.

Routine Inspections: The parks and recreation department's director, Tim Crawford, conducts monthly informal inspections. An annual inspection is conducted by Tennessee Municipal League Loss Control specialist. Informal weekly inspections are performed by various staff who work in the recreation areas, primarily looking for signs of vandalism. Any damage or potential safety hazards will be addressed as soon as possible by parks and recreation staff. Minor damage may be repaired by qualified city staff, using available funds. When necessary, a contractor may be used to repair damages or replace equipment, following the city's standard purchasing procedures. Damage that requires an insurance claim or police report shall be reported to the City Recorder.

Restricted Access: If at any time any facility is deemed unsafe, it is immediately lined off with police or construction tape until the problem is remedied. Access is not permitted until the problem is resolved.

Trash Receptacles: Trash receptacles are available near the area and are emptied daily during the season. City staff also remove litter when necessary. Several locations are covered by security cameras.

Playground Maintenance Plan

Purpose: To outline the guidelines for maintenance of city-owned playgrounds

Financial Resources: The City of Sweetwater provides a line item in the annual budget within the parks and recreation department for playground maintenance. The Parks and Recreation Director or his designee shall have authority to disburse the budgeted funds for routine playground maintenance as needed. The city also employs a full time parks and recreation department with at least one employee trained specifically for playground inspection.

Financial Administration: The playgrounds currently located on city property include the Recreation Complex playground and the Engleman Park playground. Both are funded and maintained through the city's budget, according to the city's purchasing and accounting policies. Funding is ultimately determined by the Mayor and Board of Commissioners. Donations for playground funds are placed in a restricted account dedicated to parks and recreation improvements. The City covers both property and casualty coverage on their blanket policies.

Staff Qualifications: The parks and recreation department has at least one staff member trained for playground maintenance. Currently, the playground supervisor is Tim Crawford. Tim has attended the Playground Safety Inspector course, sponsored by National Recreation and Parks Association, both in 2011 and 2012. Director Tim Crawford and Laborer Michael Jenkins have both attended the Parks & Recreation Maintenance Management School in Wheeling, WV in 2013 and 2015 respectively.

Routine Inspections: The parks and recreation department's director, Tim Crawford, conducts monthly formal inspections, using an approved checklist, attached as Appendix A. Records are kept on file by Mr. Crawford and kept available for public inspection in the City Recorder's office. An annual inspection is conducted by Tennessee Municipal League Loss Control specialist. Informal weekly inspections are performed by various staff who work in the recreation areas, primarily looking for signs of vandalism. Any damage or potential safety hazards will be addressed as soon as possible by parks and recreation staff. Minor damage may be repaired by qualified city staff, using available funds. When necessary, a contractor may be used to repair damages or replace equipment, following the city's standard purchasing procedures. Damage that requires an insurance claim or police report shall be reported to the City Recorder.

Restricted Access: If at any time any piece of equipment is deemed unsafe, it is immediately lined off with police or construction tape until the problem is remedied. Access is not permitted until the problem is resolved.

Trash Receptacles: Trash receptacles are available near the area and are emptied weekly, and sometimes more often depending on usage. A volunteer removes litter from the area three times per week. City staff also removes litter when necessary.

Playground Equipment Purchasing and Warranty: Any new equipment purchases or repair needs will follow the city's purchasing procedures for quotes, bidding, records, and accounting. When new equipment is purchased, a copy of the applicable warranty will be kept with the purchasing documents in the Recorder's office. Significant damage or vandalism shall be reported to the City Recorder upon discovery. If a police report is deemed necessary, witness reports should be obtained by recreation staff or the police department.

Court Maintenance Plan

The basketball and tennis courts are inspected weekly for vandalism or wear. Items such as net replacement and surface maintenance are addressed as needed. Windbreakers are secured at least weekly.

SECTION 4: PUBLIC ENGAGEMENT AND SURVEY

As part of the planning process, citizens of Sweetwater were asked to partake in strategic planning through a public meeting to discuss the usage of the city's parks. During the meeting, citizens of Sweetwater engaged with public officials and East Tennessee Development District staff. Individuals were asked to take a sticky note and pin their thoughts onto a satellite map of each park. Meeting attendees also completed a survey to provide input on the current state of recreation in Sweetwater and the level of public engagement with existing facilities. This same survey was conducted both in person and online via SurveyMonkey. The results of the public engagement were analyzed and provided direction for Sweetwater and ETDD to move forward with the development of the parks plan utilizing public input and suggestions. Survey results are presented in Table 4-1.

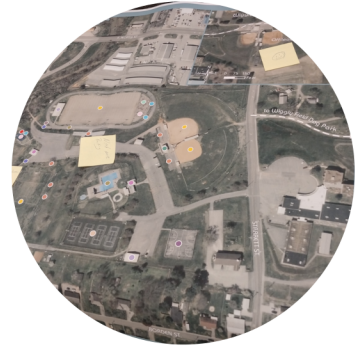

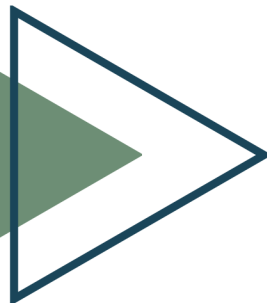

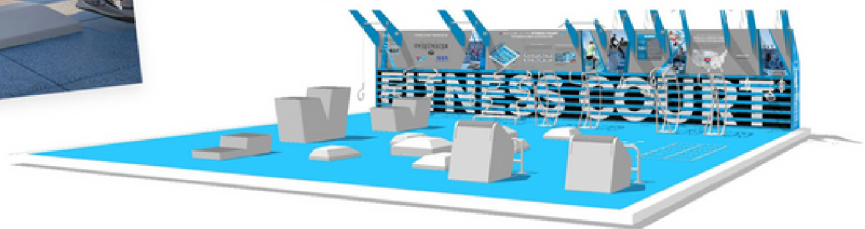

New Facilities

The Sweetwater Parks and Recreation Department with the help of City government and East Tennessee Development District, is currently in the process of constructing a brand new Community Center that will be a fitness jewel to the city. The facility will include multisport courts for a variety of games, classrooms, kitchen, and event space.

Along with the construction of the center, the NFC Fitness Court (compatible with mobile app) was unveiled in Fall 2021 at the Sweetwater Recreation Complex. The construction of this facility is in alignment with the recreation goals of the city as well as a huge accomplishment as it is the first city in Tennessee with a NFC Fitness Court!

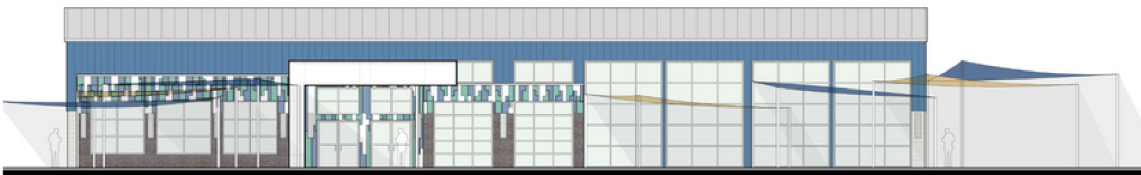

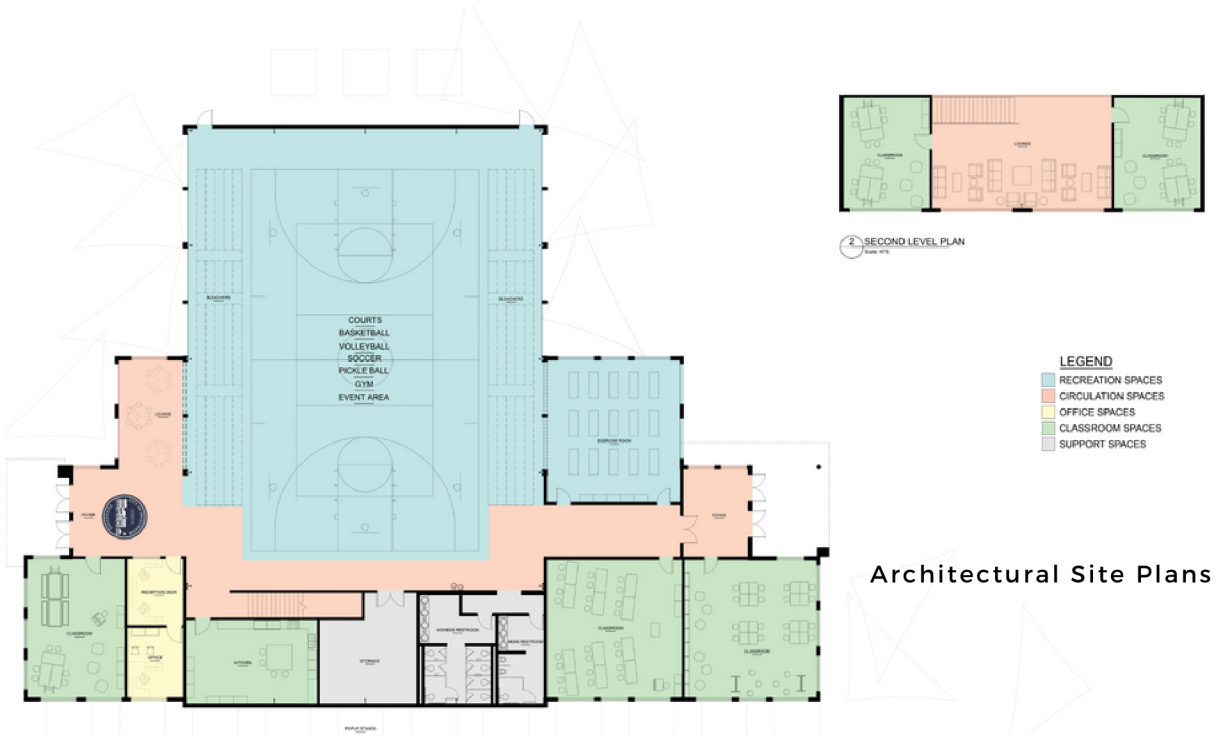

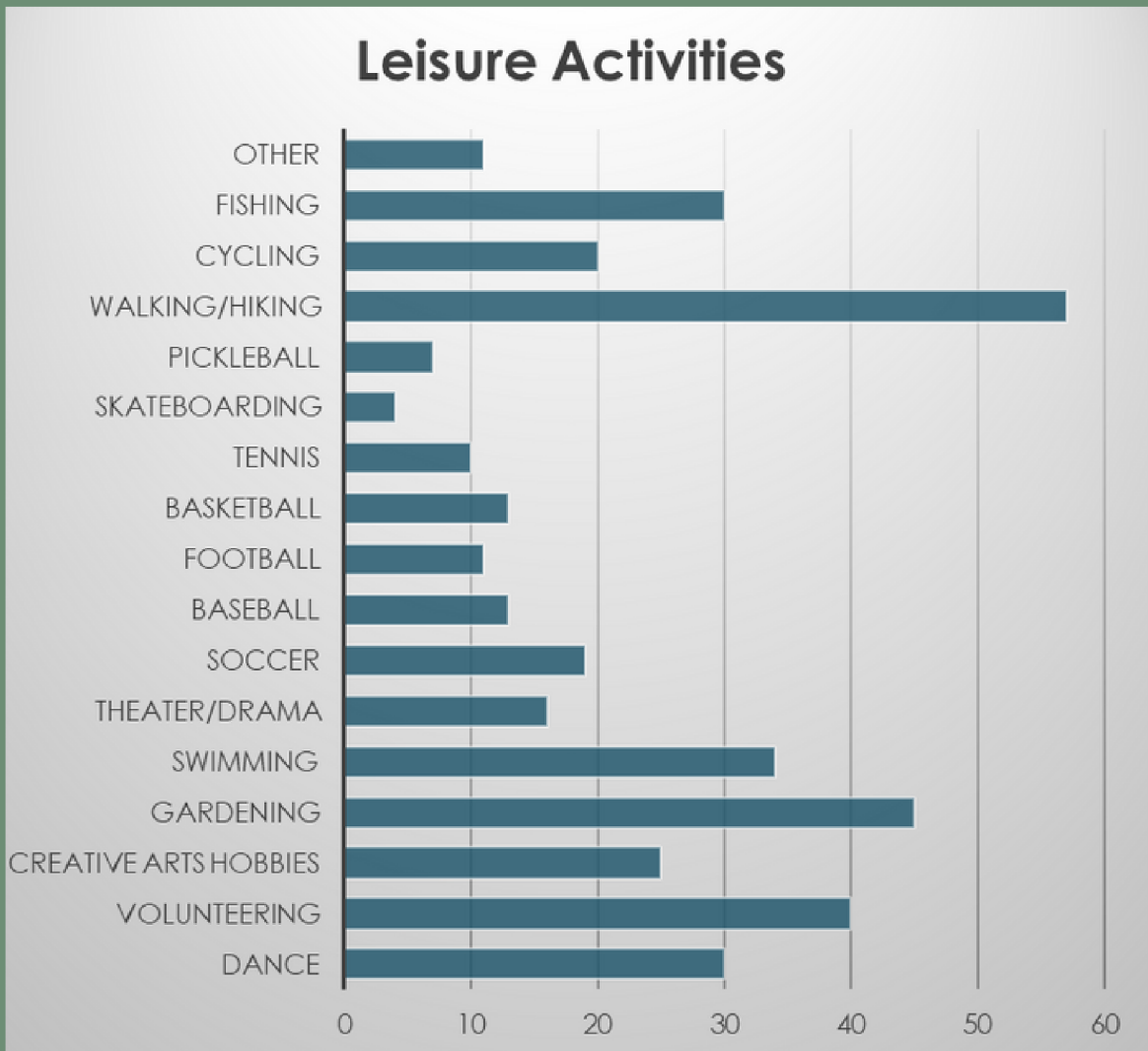
